ORDINANCE STRS L3 ACQ8 LLC Acct. No. 416079-1 Permit No. 1127780

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to STRS L3 ACQ8 LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use eleven (11) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 1504 N. Fremont St..

Said Canopy(s) at N. Fremont Street measure(s):

Seven (7) at fourteen (14) feet in length, and two point four two (2.42) feet in width for a total of two hundred thirty-seven point one six (237.16) square feet.

Said Canopy(s) at N. Fremont Street measure(s):

One (1) at four point nine two (4.92) feet in length, and two point four two (2.42) feet in width for a total of eleven point nine one (11.91) square feet.

Said Canopy(s) at N. Blackhawk Street measure(s):

Three (3) at fourteen point five eight (14.58) feet in length, and two point five eight (2.58) feet in width for a total of one hundred twelve point eight five (112.85) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127780 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.
