BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Traffic Safety

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

- WARD LOADING ZONES/STANDING ZONES:
- 11642 West 43rd Street; 642 West 43rd Street (north side) from a point 84 feet west of
South Lowe Avenue to a point 20 feet west thereof; 15 Minute Standing Zone, Use Flashing Lights,
9:00am to 8:00pm, Monday through Saturday (17-02349985) [02017-2020]

WARD AMEND LOADING ZONES / STANDING ZONES:

- 1 1924 West Division Street; Amend Ordinance Passed 08/30/2000, journal page 39798, which reads: 1924 West Division Street (north side) from a point 240 feet west of North Wolcott Avenue to a point 25 feet west thereof; No Parking Loading Zone, 6:00am to 12:00am, by Striking: 25 feet and Inserting: 45 feet in lieu thereof - (17-02350361) [02017-1958]
- 35 3030 North Kedzie Avenue; Repeal Ordinance Passed 06/28/2000, journal page 36869 which reads: Amend Loading Zone by Striking the Original Times and Inserting the Hours 6:30am to 5:30pm, by Striking the above.  11:00pm, All Days, by Striking the above (17-02296479) [02017-2278]
- 47 North Ashland Avenue; Amend Ordinance which Passed 09/10/2008, journal page 36770, which reads: North Ashland Avenue (west side) from a point 147 feet north of West Waveland Avenue to a point 25 feet north thereof; 30 Minutes Loading Zone, Use Flashing Lights, 8:00am to 8:00pm, Monday through Saturday, by Striking: 25 feet and Inserting: 40 feet in lieu thereof-- (17-02144662) [02017-2033]
