ORDINANCE 1980 Milwaukee LLC Acct. No. 417683 - 1 Permit No. 1128566

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 1980 Milwaukee LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Cornice(s) projecting over the public right-of-way adjacent to its premises known as 1980 N. Milwaukee Ave..

Said Cornice(s) at N. Milwaukee Ave measure(s):

One (1) at forty-nine point nine two (49.92) feet in length, and two point four two (2.42) feet in width for a total of one hundred twenty point eight one (120.81) square feet. Existing cornice is approximately thirty-six (36) feet two (2) inches above level.

One (1) at forty-nine point nine two (49.92) feet in length, and point five (.5) feet in width for a total of twenty-four point nine six (24.96) square feet. Existing cornice is approximately twenty-six (26) feet two (2) inches above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128566 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
