ORDINANCE OLD FRANKLIN L L C. Acct. No. 88115-1 Permit No. 1128436

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to OLD FRANKLIN L.L.C., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Awning(s) projecting over the public right-of-way adjacent to its premises known as 537 S. Dearborn St..

Said Awning(s) at S. DEARBORN measure(s):

One (1) at twelve point eight (12.8) feet in length, and two point five (2.5) feet in width for a total of thirty-two (32) square feet.

Said Awning(s) at S. DEARBORN measure(s):

One (1) at nine point three (9.3) feet in length, and two point five (2.5) feet in width for a total of twenty-three point two five (23.25) square feet.

Said Awning(s) at S. DEARBORN measure(s):

One (1) at nine point three (9.3) feet in length, and two point five (2.5) feet in width for a total of twenty-three point two five (23.25) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128436 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.
