BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the C3-1 Neighborhood Commercial District and M2-3 Light Industry District symbols and indications as shown on Map No. 12-1 in the area bounded by:
