ORDINANCE GIC 11 E. Walton LLC Acct. No. 399965 - 1 Permit

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GIC 11 E. Walton LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Sheeting(s) under the public right-of-way adjacent to its premises known as 11 E. Walton St..

Said Sheeting(s) at E. Walton Street measure(s):

One (1) at one hundred twenty-six point two five (126.25) feet in length, and one point five (1.5) foot in width for a total of one hundred eighty-nine point three eight (189.38) square feet. Existing sheeting is approximately forty (40) feet in depth.

Said Sheeting(s) at N. State Street measure(s):

One (1) at one hundred twenty-six point nine two (126.92) feet in length, and three point one six (3.16) feet in width for a total of four hundred one point zero seven (401.07) square feet. Existing sheeting is approximately forty (40) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128151 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
