### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 5-1 in the area bounded by:**

**A line 350 feet South of and parallel to West Wabansia Avenue; the public alley next East of and parallel to North Humboldt Boulevard; a line 400 feet South of and parallel to West Wabansia Avenue; North Humboldt Boulevard.**

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

**SECTION 2. This Ordinance takes effect after its passage and due publication.**
