ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That the Chicago Zoning Ordinance be amended by changing all C1-1 Neighborhood Commercial District symbols and indications as shown on Map No. 1-G in the area bounded by

a line 99.89 feet north of and parallel to West Fulton Market Street, a line 151.07 feet east of and parallel to North Sangamon Street; West Fulton Market Street; and North Sangamon Street;

to those of the DS-3 Downtown Service District and a corresponding use district is hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from and after its passage and due publication.
