UNIVERSITY OF CHICAGO Acct. No. 43697- 106 Permit No. 1128781

Se It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Trench(s) under the public right-of-way adjacent to its premises known as 5850-5900 S. Dorchester Ave..

Existing Utility Trench at 5850 S. Dorchester Avenue measure(s):

One (1) chilled water supply pipe at sixty-six (66) feet in length and twenty-four (24) inches in diameter.

One (1) chilled water return pipe at sixty-six (66) feet in length and twenty-four (24) inches in diameter.

Four (4) NSIT pipes at sixty-six (66) feet in length and four (4) inches in diameter.

One (1) compressed air pipe at sixty-six (66) feet in length and four (4) inches in diameter.

Existing utility trench is approximately ten (10) feet depth.

Existing Utility Trench at 5900 S. Dorchester Avenue measure(s):

One (1) water supply pipe at sixty-six (66) feet in length and twenty-four (24) inches in diameter.

One (1) chilled water return pipe at sixty-six (66) feet in length and twenty-four (24) inches in diameter.

Four (4) NSIT pipes at sixty-six (66) feet in length and four (4) inches in diameter.

One (1) compressed air pip at sixty-six (66) feet in length and four (4) inches in diameter.

Existing utility trench is approximately ten (10) feet in depth.

Existing Utility Trench at 5900 S. Dorchester Avenue measure(s):

One (1) chilled water supply pipe at one hundred fifty-seven (157) feet in length and twenty-four (24) inches in diameter.

One (1) chilled water return pipe at one hundred fifty-seven (157) feet in length and twenty-four (24) inches in diameter.

Four (4) NSIT pipes at one hundred fifty-seven (157) feet in length and four (4) inches in diameter.

One (1) compressed air pipe at one hundred fifty-seven (157) feet in length and four (4) inches in diameter.

Existing utility trench is approximately ten (10) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128781 herein granted the sum of eight thousand four hundred (\$8,400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the-City performing work in the public way.
