ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all off the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 13 - K in the area bounded by:

A line 106.80 feet South of and parallel to West Ainslie Street; a public alley next East of and parallel to North Keystone Avenue; the public alley next South of and parallel to West Ainslie Street; North Keystone Avenue.

To those of an RM4.5, Residential Multi-Unit District
