BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Commissioner of Transportation is hereby authorized and directed to establish and/or amend School Parking Restriction Signs at the below listed locations:

WARD MISCELLEANEOUS:

- 12 3701-3741 South St Louis Avenue; 3701-3741 South St Louis Avenue (west side); No Parking Except Official School Personnel Permit Parking, 8:00am to 4:00pm, Monday through Friday, School Days [02017-6147]
- 20 4711-4759 South Bishop Street; 4711-4759 South Bishop Street (east side) from a point 175 feet south of West 47th Street to a point 425 feet south thereof; No Parking School Days Except School Personnel, 7:00am to 4:30pm - (17-04638637) [02017-3934]
- 22 2728-2738 South Kostner Avenue; No Parking School Personnel Parking Only, 7:30am to 4:30pm, Monday through Friday, School Days [02017-6165]
- 23 South Karlov Avenue; South Karlov Avenue (west side) from West 61st Street to West 60th Street; No Parking School Days Except for School Personnel, 7:00am to 4:30pm, School Days - (17-00435361) [02017-399]
- 23 West 60th Street; West 60th Street (south side) from South Keeler Avenue to South
