BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 3 - G in the area bounded by:

The public alley next North of and parallel to West Evergreen Avenue; a line 125 feet East of and parallel to North Noble Street; West Evergreen Avenue; a line 100 feet East of and parallel to North noble Street.
