BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 5-1 in the area bounded by:

West Armitage Avenue; a line 105.5 feet West of and parallel to North Whipple Street; the public alley next South of and parallel to West Armitage Avenue; a line 130.50 feet West of and parallel to North Whipple Street.

To those of a B2-3, Neighborhood Mixed-Use District
