ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by
changing all the CI-2 Neighborhood Commercial District symbols and indications as shown on
Map No. 17-H in the area bounded by

beginning at a line 93 feet north of the intersection of West Greenleaf Avenue and North
Clark Street as measured at the easterly right-of-way of North Clark Street and
perpendicular thereto; the alley next east of North Clark Street; West Greenleaf Avenue;
and a line from a point 100 feet east of South Clark Street and the north right-of-way line
of West Greenleaf Avenue; to a point 99.41 feet east of North Clark Street and 96.53 feet
north of West Greenleaf Avenue running north to the point of beginning,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



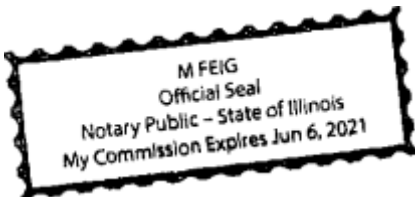
