ORDINANCE PHUOC LE
Acct. No. 366770 - 1 Permit
No. 1128741

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PHUOC LE, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, Occupation of Space on the public right-of-way adjacent to its premises known as 5043-45 N. Clark St. Existing occupation of space is used for a portion of a three (3) story building encroaching on the public right-of-way adjacent to its premises known as 5053-45 North Clark Street. Exiting three (3) story building encroach over the property line one (1) foot four (4) inches in depth and twenty-five (25) feet in length for a total of thirty-three point two five (33.25) square feet along North Clark Street.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128741 herein granted the sum of zero (\$0.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 01/18/2017.
