RESOLUTION FOR THE GRAY'S 60TH WEDDING ANNIVERSARY

WHEREAS, This esteemed body has been notified of the Gray's milestone by the Honorable Marty Qutnn, Alderman of the 13th Ward, and the Honorable Michael Zalewski, Alderman of the 23rd Ward; and

Gene also has volunteered at the Center and they have both been volunteer coaches at Clear Ridge baseball. Gene also ran the Community Economic Development Association Program for State Representative Dan Lipinski's office assisting low-income senior citizens in receiving affordable electric and gas service; and

WHEREAS, The Grays have six grandchildren and five great-grandchildren, with another great-granddaughter expected next month. They are wonderful examples of a loving couple who built a strong family and have greatly enhanced their community; now, therefore,
