TRAFFIC LANE - TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD	TOW ZONES:
1	North Bishop Street; North Bishop Street (west side) from West Grand Avenue to West Ohio Street; No Parking Tow Zone Except for Official School Personnel Parking Only, 6:00am to 6:00pm, School Days - (17-06138906) [02017-7332]
27	1100 West Grand Avenue; 1100 West Grand Avenue (north Side) from North Aberdeen Avenue to the first alley west thereof; No Parking Tow Zone [02017-7642]
27	1801 West Fulton Street; 1801 West Fulton Street (south side) from a point 100 feet west of North Wood Street; No Parking Tow Zone [02017-7648]
32	West Fullerton Avenue; West Fullerton Avenue (south side) from North Sacramento Avenue to the first alley east thereof; No Parking Tow Zone, All Times, All Days --(17-06138562) [02017-7551]
42	. East Superior Street; East Superior Street (north side) from North Wabash Avenue to a point 100 feet east thereof and East Superior Street (south side) from North Wabash Avenue to a point 60 feet east thereof and from a point 180 feet east of North Wabash Avenue to North Rush Street; No Parking Tow Zone, All Times, All Days --(17-04914525) [02017-4249]

42 435 East Illinois Street; East Illinois Street (south side) from a point 241 feet east of North McClurg Court to a point 180 feet east thereof; No Parking, No Stopping, No Standing - (17-02090682) [02017-2057]

WARD AMEND TOW ZONES:

45 3600-3699 North Central Park Avenue; Repeal Ordinance which reads: 3600-3699 North Central Park Avenue (west side); No Parking Tow Zone, 8:00am to 10:00am, Monday through Friday, by Striking the above [02017-6354]

SECTION 2. This ordinance shall take effect and be in force here in after its passage and publication.
