## ORDINANCE

### ***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-1 Community Shopping District symbols and indications as shown on Map No 3-1 in the area bounded by

a line 125.0 feet north of and parallel to West Thomas Street; North California Avenue; a line 75 feet north of and parallel to West Thomas Street: and the alley next west of and parallel to North California Avenue,

to those of a Cl-2 Neighborhood Commercial District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
