ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. On December 13, 2017, the City Council of the City of Chicago passed an ordinance, referenced as O2017-8426, amending Titles 2, 4 and 7 of the Municipal Code of Chicago regarding food and food-related health regulations (the "Food Regulation Ordinance"). SECTION 6 of the Food Regulation Ordinance is hereby amended by inserting the language underscored, as follows:

SECTION 6. New subsection 2-112-160(a)(7). inserted by SECTION 1 of this ordinance, shall take effect upon this ordinance's passage and approval. After passage and publication approval, the remainder of this ordinance shall take effect on July 1, 2018.

SECTION 2. This ordinance shall take effect upon its passage and approval, and shall apply retroactively to the date of passage and approval of the Food Regulation Ordinance.
