**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Pursuant to Section 10-20-430 of the Municipal Code of Chicago,  
**Commissioner of Transportation is hereby authorized and directed to exempt  
Jeannette Gacharna of Brasa Roja Corp. from the provisions requiring  
barriers as a prerequisite to prohibit alley ingress and egress to 2214 North  
Cicero Avenue.**
