### ORDINANCE

WHEREAS, The management of its finances is a matter pertaining to the government and affairs of the City of Chicago; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: The City Comptroller and the City Treasurer are authorized and directed to make the following transfer of funds for the year 2017. This transfer will leave sufficient unencumbered appropriations to meet all liabilities that have been or may be incurred during the year 2017 payable from such appropriations:
