Your Committee on Pedestrian and Traffic Safety begs leave to recommend that Your Honorable Body DO NOT PASS the sundry proposed ordinance(s) and/or order(s) submitted herewith which were referred to the Committee on Pedestrian and Traffic Safety concerning Traffic Regulations and Traffic Signs, et cetera as follows:

**V. The following items were NOT RECOMMENDED by the City Department(s) and FAILED TO PASS:**

**WARD PARKING PROHIBITED AT ALL TIMES - DISABLED:**

31 4830 West Henderson Street, Disabled Permit 92474 [O2017-7994]

**WARD RESIDENTIAL PERMIT PARKING ZONES:**

24 3800-3899 West Grenshaw Street; Residential Permit Parking Zone. Not Recommended. Duplicate previously passed 02/22/2017 [Or2017-473]

33 4500-4599 North Troy Street; 4500-4599 North Troy Street (east and west sides); Residential Permit Parking Zone. Not Recommended [Or2017-597]

**WARD AMEND RESIDENTIAL PERMIT PARKING ZONES:**

- 13            5800-5899 South Kilbourn Avenue; Amend Residential Permit Parking Zone 345, which reads: 5800-5899 South Kilbourn Avenue (north and south sides) from west 58th Street to West 59th Street, and on West 58th Street (south side) from South Kilbourn Avenue east to the first alley and from South Kilbourn Avenue west to the first alley, All Times, All Days, by Striking: Residential Permit Parking Zone 345 and Inserting: a new Residential Permit Parking Zone number, in lieu thereof [02017-8625]

- 31            North Kostner Avenue; North Kostner Avenue between West Diversey Avenue and West Belmont Avenue: Single Direction - Southerly. Not Recommended. - 19            South Longwood Drive and West 101st Place; Stop Sign. Not Recommended. Duplicate Proposal previously Passed 12/13/2017. Signs will be installed --(17-08067463) [02017-8368]
- 19            South Homan Avenue; No Trucks Sign. Not Recommended: Duplicate proposal previously Passed 12/13/2017. Signs will be installed - (17-08067817) [02017-8366]
