#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the Bl-3 Neighborhood Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

West Howard Street; the alley first west of and parallel to North Ashland Street; the public alley running northwest and southeast and parallel to the Northwestern Elevated Railroad (C. M. St. P. & P.R.R.) right-of-way; the Northwestern Elevated Railroad (C. M. St. P. & P.R.R.) right-of-way; and a line beginning at a point located on said right-of-way, 251.76 feet west of and parallel to the alley first west of and parallel to North Ashland Street

to those of a B3-3 Community Shopping District, and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

#### Description of Subject Property and Nature, Scope and Purpose of Proposal:

The subject property is currently improved with surface parking (67 spaces) and a three-story building (approximately 52' in height) that has 40 residential units on the second and third floors, with approximately 14,500 square feet of commercial/retail space at ground level. No physical alterations to the subject property are planned at this time other than minor alterations of an existing, vacant ground-floor commercial storefront for a new General Restaurant (i.e., a restaurant that may serve liquor at a separate bar area within the restaurant, in addition to table service). At this time, the specific new General Restaurant planned for that space is Salerno's Pizza and Restaurant, which presented its proposal at. a December 6, 2017 community meeting convened by Alderman Moore and announced in his emailed newsletter on November 29, 2017. The purpose of this rezoning is to allow the property to have the broader range of commercial tenants, like a Salerno's General Restaurant, that are allowable with B3 District zoning classification but not Bl. This type of rezoning would not allow the subject property to increase building size, building height or numbers of residential dwelling units.

Remedies at law for a false statement of material fact may include incarceration and an award to the City of treble damages.
- D. It is the City's policy to make this document available to the public on its Internet site and/or upon request. Some or all of the information provided in, and appended to, this EDS may be made publicly available on the Internet, in response to a Freedom of Information Act request, or otherwise. By completing and signing this EDS, the Disclosing Party waives and releases any possible rights or claims which it may have against the City in connection with the public release of information contained in this EDS and also authorizes the City to verify the accuracy of any information submitted in this EDS.
- E. The information provided in this EDS must be kept current. In the event of changes, the Disclosing Party must supplement this EDS up to the time the City takes action on the Matter. If the Matter is a contract being handled by the City's Department of Procurement Services, the Disclosing Party must update this EDS as the contract requires.
