BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 District symbols and indications as shown on Map No. 10-1 in the area bounded by:

A line 38 feet north of and parallel to Pope John Paul II Drive; the public alley next east and parallel to South Sacramento Avenue; Pope John Paul II Drive; and South Sacramento Ave.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
