Se It Ordained by the City Council of the City of Chicago.

SECTION 1 Permission and authority are hereby given and granted to XSPORT FITNESS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, thirteen (13) Awning(s) projecting over the public right-of-way adjacent to its premises known as 210-30 W. North Ave..

Said Awnmg(s) at W North Avenue measure(s).

Three (3) at ten point six seven (10.67) feet in length, and four point five (4.5) feet in width for a total of one hundred forty four point zero five (144 05) square feet.

One (1) at ten point six seven (10.67) feet in length, and four point five (4.5) feet in width for a total of forty-eight point zero two (48.02) square feet

One (1) at ten point six seven (10.67) feet in length, and four point five (4.5) feet in width for a total of forty-eight point zero two (48.02) square feet

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1131748 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way
