ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Single Unit (Detached House) District symbols and indications as shown on Map No. 13-H in an area bound by

A line 107 feet East of and parallel to North Hoyne Avenue; the alley next North of and parallel to West Foster Avenue; a line 167 feet East of and parallel to North Hoyne Avenue, West Foster Avenue

to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District. SECTION 2. This ordinance takes effect after its passage and due publication.
