ORDINANCE

Haymarket Apartments Joint Venture LP Acct. No.

424899 - 1 Permit No. 1132179

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to Haymarket Apartments Joint Venture LP, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Bollard(s) on the public right-of-way adjacent to its premises known as 939 W. Washington Blvd..

Said Bollard(s) at N. Sangamon Street measure(s):

Two (2) at one (1) foot in length, and point five (5) feet in width for a total of one (1) square feet. Said

Bollard(s) at N. Morgan Street measure(s):

Two (2) at one (1) foot in length, and point five (.5) feet in width for a total of one (1) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1132179 herein granted the sum of three hundred (\$300.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs
