ORDINANCE BROADWAY 5050, LLC Acct. No. 425338 -1 Permit

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to BROADWAY 5050, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use fourteen (14) Tree Grates(s) on the public right-of-way adjacent to its premises known as 5050 N. Broadway.

Said Tree Grates(s) at N BROADWAY measure(s):

Eight (8) at ten (10) feet in length, and five (5) feet in width for a total of four hundred (400) square feet. Said Tree

Grates(s) at W WINNEMAC AVE measure(s):

Three (3) at ten (10) feet in length, and five (5) feet in width for a total of one hundred fifty (150) square feet. Said

Tree Grates(s) at W CARMEN AVE measure(s):

Three (3) at ten (10) feet in length, and five (5) feet in width for a total of one hundred fifty (150) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1132089 herein granted the sum of zero (\$.00) per annum in advance.


A 25% penalty will be added for payments received after due date.
