ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, as shown on Map 20-E in the area bounded by:

South Rhodes Avenue, a line 171 feet south of East 79th Street, the alley west of and parallel to South Rhodes Avenue and a line 216 feet south of East 79th Street.

To those of RM-5 Residential Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
