ORDINANCE

7T ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the Bl-3 Neighborhood Shopping District symbols and indications as shown on Map No. 13-H in the area bounded by

the alley next north of and parallel to West Lawrence Avenue; a line 102.50 feet west of and parallel to North Winchester Avenue; West Lawrence Avenue; and a line 147 feet west of and parallel to North Winchester Avenue,

to those of a B3-3 Community Shopping District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Proposed Land Use: The Applicant is seeking a zoning change in order to permit the

construction of a new four-story vertical addition above the existing one-story (with basement) building, at the subject site. The newly renovated and expanded building will contain commercial/retail space - between the basement and 1st Floor, and a total of twelve (12) dwelling units - above (2nd thru 5^{Ul} Floors). 
