ORDINANCE

THE CONTEMPORAINE CONDOMINIUM ASSOCIATION Acct. No.

313823-1 Permit No. 1132850

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to THE CONTEMPORAINE CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use five (5) Security Camera(s) projecting over the public right-of-way for security purposes adjacent to its premises known as 516 N. Wells St..

Said Security Camera(s) at W. Grand Avenue measure(s):

One (1) at point five (.5) feet in length, point five (.5) feet in width and fourteen (14) feet above grade level. Said

Security Camera(s) at N. Wells Street measure(s):

Two (2) at point five (.5) feet in length, point five (.5) feet in width and fourteen (14) feet above grade level. Said

Security Camera(s) at Public Alley measure(s):

Two (2) at point five (.5) feet in length, point five (.5) feet in width and fourteen (14) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1132850 herein granted the sum of zero (\$.00) per annum in advance.
