#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current RS-3 Residential Single-Unit (Detached House) Districts symbols and indications as shown on Map No. 9-H in the area bounded by:

West Addison Street; a line 33.00 feet west of and parallel to North Marshfield Avenue; the public alley next south of West Addison Street; and a line 66.00 feet west of and parallel to North Marshfield Avenue

to those of a RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit Districts. SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.




