SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1 -2 Limited Manufacturing/Business Park District Osymbols and indications as shown on Map No. 13-H in an area bound by

The alley next west of and parallel to North Damen Avenue; West Rascher Avenue; North Damen Avenue; a line 108 feet South of and parallel to West Rascher Avenue

to those of an M2-2 Light Industry District.

SECTION 2. This ordinance takes effect after its passage and due publication.
