BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 1-G in an area bound by

A line 45.00 feet West of and parallel to North Bishop Street; a line 93.00 feet North of and parallel to West Huron Street; North Bishop Street; and West Huron Street

to those of an RT3.5 Residential two-Flat, Townhouse and Multi-Unit District.
