ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 8-H in the area bounded by:

The public alley next south of West 35 Street; the public alley next east of South Oakley Avenue; a line 193.75 feet south of and parallel to West 35th Street; and South Oakley Avenue

to those of a RS-3 Residential Single-Unit (Detached House) District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

3515-19 South Oakley Avenue TYPE I REGULATIONS

Narrative: The property measures 6,639 square feet and is currently a vacant lot. The Applicant proposes to rezone the property from an MI-2. Limited Manufacturing/Business Park District to an RS-3 Residential Single-Unit (Detached House) District for the construction of two two-story single family homes with detached two car garages on 3515 and 3519 South Oakley Avenue. The height of both single family homes will be 26 feet and 3 inches.
