ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 18-C in an area bound by

A line 75 feet West of and parallel to South East End Avenue; the alley next North of and parallel to East 79th Street; South East End Avenue; East 79th Street

to those of a B3-lCommunity Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
