Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 1-L in the area bounded by:

A line 30 feet north of and parallel to West Ohio Street; North Lockwood Avenue; West Ohio Street; the public alley next west of and parallel to North Lockwood Avenue.
