ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS2 Residential Single-Unit (Detached House) District symbols as shown on Map No. 16-J in the area bounded by:

West 68th Street; the public alley next east of and parallel to South Pulaski Road; a line 57.89 feet south of and parallel to 68th Street; South Pulaski Road.

To those of a BI-1, Neighborhood Shopping District

SECTION 2. This Ordinance takes effect after its passage and due publication.
