### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 7-J in the area bounded by:**

**West Diversey Avenue; a line 52.44 feet west of and parallel to North Ridgeway Avenue; the public alley next south of and parallel to West Diversey Avenue; a line 79.44 feet west of and parallel to North Ridgeway Avenue.**

**To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2. This**

Ordinance takes effect after its passage and due publication.
