ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.1-G in the area bounded by

a line 294 feet north of and parallel to West Huron Street; North Elizabeth Street; a line 270 feet north of and parallel to West Huron Street; and the alley next west of and parallel to North Elizabeth Street,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District is hereby established in the area above described.

SECTION2. This ordinance shall be in force and effect from and after its passage and due publication.
