## **ORDINANCE**

TREVINO'S LIQUORS INC Acct. No.

26059 -1 Permit No. 1133515

Be It Ordained by the City Council of the City of Chicago.

SECTION 1 Permission and authority are hereby given and granted to TREVINO'S LIQUORS INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Awning(s) projecting over the public right-of-way adjacent to its premises known as 4135 W. 31st St..

Said Awning(s) at West 31st Street & south Kedvale Avenue measure(s):

One (1) at seven point five seven (7.57) feet in length, and four point three three (4.33) feet in width for a total of thirty-two point seven eight (32.78) square feet.

Said Awning(s) at West 31st Street measure(s).

One (1) at seventeen point six seven (17.67) feet in length, and two (2) feet in width for a total of thirty-five point three four (35.34) square feet.

Said Awning(s) at South Kedvale Avenue measure(s)'

One (1) at thirty-one (31) feet in length, and two (2) feet in width for a total of sixty-two (62) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1133515 herein granted the sum of one hundred fifty-six (\$156.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
