ORDINANCE RED ROOF INN #10281 Acct. No. 406793 - 1

Permit No. 1131929

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RED ROOF INN #10281, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 162 E. Ontario St..

Said Awning(s) at E. Ontario Street measure(s):

One (1) at eight (8) feet in length, and fifteen point nine two (15.92) feet in width for a total of one hundred twenty-seven point three six (127.36) square feet.

Said Awning(s) at E. Ontario Street measure(s):

Two (2) at six point two five (6.25) feet in length, and three (3) feet in width for a total of thirty-seven point five (37.5) square feet

Said Awning(s) at N. St clair Street measure(s)

One (1) at six point two five (6.25) feet in length, and three (3) feet in width for a total of eighteen point seven five (18.75) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1131929 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
