ORDINANCE MESSAGE ENVY Acct.
No. 315229-1 Permit No. 1132240

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MESSAGE ENVY, upon the terms and subject to the conditions of this ordinance to maintain and use one (1) sign(s) projecting over the public right-of-way attached to its premises known as 345 E. Ohio St..

Said sign structure(s) measures as follows; along E. Ohio Street:

One (1) at eleven point zero eight (11.08) feet in length, one point five (1.5) feet in height and fifteen (15) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1132240 herein granted the sum of one hundred (\$100.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

PLEASE NOTE Your franchise insists upon having NO EXPOSED CONDUIT on the exterior of the fascia. It is at the owner's cost and the owner is responsible to coordinate this with their electrician prior to having the sign installed. If it is found at the time of installation that electrical conduit will be exposed, the sign company has been advised not to install the signage per your franchise and the owner is subject to additional trip charges per your franchise.

If it is determined by the owner that the sign will be exposed in any other way to provide a dedicated circuit for the exterior signage, the owner must request approval to have exposed conduit from James Copley, your franchise contact and South Whitefish Signs must be informed of approvals in writing at least 2 weeks prior to the scheduled installation of the signage.
