ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the CI-1 Neighborhood Commercial District symbols and indications as shown on Map No. 14-F in the area bounded by

South Wentworth; the Public Alley next north of and parallel to West 61st Street; South LaSalle Street; and West 61st Street;

to those of an C2-2 Motor Vehicle-Related Commercial District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Moreover, there will be at least sixteen (16) parking spaces to serve the existing building located across the street at 6121 S. Wentworth, Chicago, IL. This off-site lot will require special use approval from the Zoning Board of Appeals.
