ORDINANCE

BE: IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and RS-2 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 17-1 in the area bounded by

to those of C1-1 Neighborhood Commercial District.

In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about June 27, 2018, the undersigned, will file an application for a change in zoning for the property located 2828 West Pratt Boulevard from a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a RS-2 Residential Single-Unit (Detached House) District to a Cl-1 Neighborhood Commercial District.

The owner of the property and the applicant of the zoning amendment is Yeshiva Ohr Boruch, The Veitzener Cheder located at 2828 West Pratt Boulevard, Chicago, IL 60645.

The applicant is requesting a zoning amendment from a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District and a RS-2 Residential Single-Unit (Detached House) District to a Cl-1 Neighborhood Commercial District to allow for a not-for-profit catering company to share the school's kitchen.
