COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties at 2422-2454 N. Elston Avenue and 2004-2050 W. Fullerton Avenue are owned by TCA-2020 West, L.L.C., an Illinois limited liability company ("Developer"); and

WHEREAS, the Developer proposes to use the portion of the street remnant to be vacated herein for a surface parking lot; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent of the public use and the public interest to be subserved is such as to warrant the vacation of that portion of the public street remnant, described in the following ordinance; now therefore.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1.

VACATION:

THAT PART OF THE SOUTHWEST QUARTER OF SECTION 30, TOWNSHIP 40 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE MOST SOUTHERN SOUTHEAST CORNER OF LOT 1 IN SNOW ESTATE SUBDIVISION, RECORDED FEBRUARY 14,1873 IN COOK COUNTY AS DOCUMENT NUMBER 80819; THENCE SOUTHEASTERLY ALONG THE EXISTING NORTHEASTERLY RIGHT OF WAY LINE OF N. ELSTON AVENUE ON AN ASSUMED BEARING OF SOUTH 46 DEGREES 15 MINUTES 46 SECONDS EAST, 275.04 FEET TO THE POINT OF BEGINNING; THENCE CONTINUING SOUTH 46 DEGREES 15 MINUTES 46 SECONDS EAST ALONG SAID LINE, 38.03 FEET; THENCE NORTH 65 DEGREES 16 MINUTES 05 SECONDS EAST, 15.51 FEET; THENCE SOUTH 1 DEGREE 31 MINUTES 57 SECONDS EAST, 114.28 FEET TO THE SOUTHWESTERLY RIGHT OF WAY LINE OF N. ELSTON AVENUE; THENCE NORTH 46 DEGREES 15 MINUTES 46 SECONDS WEST ALONG SAID LINE 257.39 FEET; THENCE EASTERLY 63.01 FEET ON A CURVE CONCAVE NORTHERLY HAVING A RADIUS OF 343.58 FEET, THE CHORD OF SAID CURVE BEARS SOUTH 64 DEGREES 25 MINUTES 18 SECONDS EAST, 62.92 FEET; THENCE EASTERLY 86.46 FEET ON A CURVE CONCAVE NORTHERLY HAVING A RADIUS OF 346.50 FEET, THE CHORD OF SAID CURVE BEARS SOUTH 78 DEGREES 48 MINUTES 32 SECONDS EAST, 86.23 FEET TO THE POINT OF BEGINNING; ALL IN COOK COUNTY, ILLINOIS.

SAID PART CONTAINING 0.222 ACRE (9,674 SQ. FT.), MORE OR LESS as shaded and legally

described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which plat for greater clarity, is hereby made a part of this ordinance; be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be subserved by such vacation.

SECTION 2. The City of Chicago hereby reserves an easement over the area herein vacated for existing Water Department sewer and associated sewer structures, and for the installation of any additional sewers, as now located, or which in the future may be located in the street herein vacated, and for the maintenance, renewal and reconstruction of such facilities. It is also provided that, the City shall have 24 hour access to the area to be vacated, that no buildings, permanent structures, or trees (within 10 feet of the sewer structure) shall be erected upon or over said easement herein reserved, or other use made of said area, which in the sole discretion ofthe respective municipal officials having control of the aforesaid service facilities, would interfere with the use, maintenance, renewal, or reconstruction of said facilities, or the construction of additional municipally-owned service facilities. It is further provided that the expenses related to any vacation-beneficiary prompted adjustments to City sewer facilities within the area herein vacated be borne by the developer, it successors or assigns, and be submitted to the Department of Water for review and express written approval prior to construction. Any repair, renewal or replacement of private improvements, or private property damaged within the vacation area as a result of the City exercising its easement rights shall be repaired/replaced at the expense of the beneficiary of the vacation, its successors or assigns.

SECTION 3. The City of Chicago hereby reserves for the benefit of The Peoples Gas Light and Coke Co. an easement to operate, maintain, repair, renew and replace existing underground facilities and to construct new facilities in all ofthe area to be vacated, with the right of ingress and egress at all times for any and all such purposes. It is further provided that no buildings or other structures shall be erected upon or over said easement herein reserved for The Peoples Gas Light and Coke Co. or other use made of the said area which would interfere with the construction, operation, maintenance, repair, removal, or replacement of said facilities, or the construction of additional facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without express written release of easement by the involved utility. Any future vacation- beneficiary prompted relocation of Peoples Gas facilities lying within the area herein vacated will be accomplished by Peoples Gas, and completed at the expense ofthe Developer, its successors or assigns

SECTION 4. The City of Chicago hereby reserves for the benefit of Commonwealth Edison, AT&T/SBC, Comcast, Wide Open West (WOW), their successors or assigns, a nonexclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services under, over and along the street herein vacated, with the right of ingress and egress. The grade ofthe vacated public way shall not be altered in a manner so as to interfere with the operation and maintenance of facilities. No construction, buildings, permanent structures or obstructions shall occur or be placed over the area herein vacated without express written release of easement by the involved utilities. Any future Developer-prompted relocation of facilities lying within the area being vacated will be accomplished by the involved utility, and completed at the expense of the beneficiary of the vacation, its successors or assigns.

SECTION 5. The City of Chicago reserves an easement for the Metropolitan Water Reclamation District, its successors or assigns a perpetual easement for facilities now located, or which in the future may be located in the street as herein vacated, and for the maintenance, renewal and reconstruction of such facilities. It is also provided that, the Metropolitan Water Reclamation District shall have 24 hour access to the area to be vacated, that no buildings or other permanent structures shall be erected, or grade changed, on said easement herein reserved, or other use made of said area, which in the sole discretion and judgment of the respective officials having control of the aforesaid service facilities, would interfere with the use, maintenance, renewal, or reconstruction of said facilities, or the construction of additional service facilities. It is further provided that the repair, renewal or replacement of any private materials, or private property damaged as a result of the Metropolitan Water Reclamation District exercising of its easement rights in the area to be vacated, be the sole expense and responsibility of the beneficiary of the vacation, its successors or assigns.

SECTION 6. In accordance with the terms of the Court Order entered on October 2, 2014, in Case No. 2014 L 50562 in the Circuit Court of Cook County, Illinois (the partial taking of land necessary for the rerouting of N. Elston Avenue), the Developer shall not be required to pay any compensation to the City for the benefits which will accrue to the owner ofthe property abutting said street remnant hereby vacated.

SECTION 7. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage ofthis ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois, a certified copy ofthis ordinance, together with the associated full sized plats as approved by the Acting Superintendent of Maps and Plats.

SECTION 8. This ordinance shall take effect and be in force from and after its passage and approval. The vacation shall take effect and be in force from and after recording of the approved ordinance and associated plat.


