BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the CI-1 Neighborhood Commercial Zoning District symbols and indications as shown on Map No. 11-K in the area bounded by

A line perpendicular to North Elston Avenue from a point 260 feet northwesterly of North Montrose Avenue as measured along the southwest line of North Elston Avenue; North Elston Avenue; a line perpendicular to North Elston Avenue from a point 210 feet northwesterly of North Montrose Avenue as measured along the southwest line of North Elston Avenue; and the alley next southwest of North Elston Avenue

to those of a C2-1 Motor Vehicle-Related Commercial Zoning District.

SECTION 2. This ordinance be in force and effect from and after its passage and due publication.
