SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on

Map No 3-J in the area bounded by

a line 50 feet north of and parallel to West Augusta Boulevard; the alley next east of and parallel to North Lawndale Avenue; West Augusta Boulevard; and North Lawndale Avenue,

to those of a RT4 Residential two-Flat, Townhouse and Multi-Unit District and a corresponding uses

district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
