CHICAGO HILTON & TOWERS Acct. No.  
210667-1 Permit No. 1135540

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to CHICAGO HILTON & TOWERS, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Kiosk(s) on the public right-of-way adjacent to its premises known as 720 S. Michigan Ave..

Said Kiosk(s) at MICHIGAN AVE & BALBOA measure(s):

One (1) at three point one six (3.16) feet in length, and one point seven five (1.75) foot in width for a total of five point five three (5.53) square feet.

Said Kiosk(s) at BALBOA & WABASH measure(s):

One (1) at three point one six (3.16) feet in length, and one point seven five (1.75) foot in width for a total of five point five three (5.53) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1135540 herein granted the sum of eight hundred (\$800.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

Authority herein given and granted for a period of five (5) years from and after 06/,
