ORDINANCE 2813 W. BELMONT LLC Acct. No. 429153-1 Permit No. 1134844

Be It Ordained by the City Council of the City of Chicago

SECTION 1. Permission and authority are hereby given and granted to 2813 W. BELMONT LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use seven (7) Caisson(s) under the public right-of-way adjacent to its premises known as 2813 W. Belmont Ave..

Said Caisson(s) at W. Belmont Avenue measure(s):

Seven (7) at two point eight three (2.83) feet in length, and seven point six seven (7.67) feet in width for a total of one hundred fifty-one point nine four (151.94) square feet. Said caissons shall be approximately thirty (30) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1134844 herein granted the sum of .four hundred (\$400.00) per annum in advance

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
